

# CARER SUBSIDY GUIDE 2022/23

These guides will assist foster carers, kinship carers and workers to understand payments associated with the care of children and young people.

## Subsidy Payments for Foster and Kinship Carers

A Subsidy payment is provided to foster and kinship carers who have a child/ren or young person/s under the care of the Director-General in their care.

Subsidy Guidelines ensure the fairest and best use of resources across the whole cohort of children and young people in care in the ACT. The Subsidy is based on the age of the child or young person and is intended to contribute to the cost of living for a child or young person regardless of their complexity of need. This includes things such as food, clothing, recreational activities and haircuts.

### 2022-2023 Foster and Kinship Care Rates

Subsidy Type	Age Groups	Weekly Rate	Who is Eligible? What is the Subsidy expected to cover?
Foster and Kinship Care, and Enduring Parental Responsibility (EPR) Rate	0-4 5-14 15-17	\$300.69 \$337.17 \$445.92	<p>Approved kinship and foster carers caring for a child for whom the Director-General has parental responsibility, or who are under an EPR order.</p> <p>This subsidy is intended to contribute towards the daily costs of caring for a child. For example: food, household provisions, household costs, clothing, footwear, school wear, education, daily travel, suitable car restraints, general medical, pharmaceuticals, general communication costs, gifts, pocket money, holidays, hobbies, activities.</p> <p>No further costs/contingency payments can be claimed under an EPR.</p>
Extended Continuum of Care	18-20	\$287.86	<p>Subject to an application, approval and review process. This extension is determined on a case-by-case basis.</p> <p>This subsidy is an extension of the Carer Subsidy and intended to contribute to the living costs of a child who remains in care after turning 18 years old.</p> <p>Approved kinship and foster carers caring for a child aged 18 – 20 (inclusive) whose Transition Plan states they will continue to live with their carer in order to be best supported may be eligible to receive this payment.</p>

Emergency Care Subsidy	0-17	\$498.21	<p>Provided to approved kinship and foster carers when emergency action sees a child needing to come into care with less than 24 hours' notice.</p> <p>This subsidy is intended to contribute to the daily care costs and establishment of the placement for the child and is paid for a maximum of 21 days while a longer-term arrangement is being organised.</p>
Respite Care Subsidy	0-17	\$402.52	<p>This rate is provided to an approved carer when they provide respite for a child on an overnight basis.</p> <p>This Subsidy is intended to cover the costs of the child/young person for a short period and is set in isolation to the needs of the usual care arrangements. The Subsidy is calculated pro-rata on a daily basis.</p>
After-Hours Rate		\$100	ACT Together pays an After-Hours Rate for new entries into Out of Home Care. \$100 a day will be paid for children placed with carers outside of business hours (after 5pm and before 9am) for a period of 7 days. After the 7 days the emergency care subsidy will be paid for each child for the next 14 days. After the 14 day period the basic subsidy will be provided for each child.

#### Notes:

- Rates are current as a 1 July 2022.
- Payments to carers are made fortnightly in arrears.
- Subsidies are tax free, not means-tested and are not affected by Australian Government Benefits that you or the child/young people may be receiving (eg youth allowance), with the exception of the Extended Continuum of Care subsidy.
- A statement of earnings may be issued for payments made outside of these rates.
- Payments under these guidelines end when the placement ends. Please contact your caseworker immediately if you think that there has been an overpayment.

Health Care Card	<p>All children and young people in the care of the Director General are eligible for a Health Care Card. This facilitates that access to medical services that bulk bill, PBS medications, Dental Health Scheme, Spectacle Support Scheme etc. Further information is available at <a href="http://www.servicesaustralia.gov.au">www.servicesaustralia.gov.au</a></p>
Bus Passes	<p>All children and young people with Health Care Cards attending ACT Government schools, are eligible for a term bus pass if they are residing outside a radius of 1km for primary school children, 2km for high school, college or students enrolled in a year 10 or 12 equivalent CIT Course. Applications must be made before the start of term and are available at <a href="http://www.assistance.act.gov.au/">www.assistance.act.gov.au/</a></p> <p>Carers living in rural areas may be eligible for allowances to assist with the costs of transporting children. Child Care Subsidy	<p>Children in foster and kinship care are eligible for the 'Additional Childcare Subsidy (child wellbeing)' which generally reduces the costs of childcare (day care, vacation care, before and after school care) to zero. Federal Government Benefits	<p>All carers and young people, should apply for Federal Government Benefits if restoration to family is not planned for in the very near future. This can include Family Tax Benefit, Parenting Payments, Double Orphan Pension, Carer Allowance, Youth Allowance and Disability Allowance. <p>ACT Spectacle Scheme</p>	<p>The Spectacles Subsidy Scheme provides eligible ACT residents with a Subsidy of up to \$200 once every two years. Eligible people for the scheme must be residents of the ACT and hold a Pensioner Concession Card from either Centrelink or the Department of Veterans Affairs, or Healthcare Card which the holder has been entitled to for three months or more. <p>TILA – Transition to Independent Living Allowance</p>	<p>TILA is a one-off practical support from the Australian Government of \$1,500, to assist some young people aged between 15 and 25 years who are making the transition from formal and informal care to Independent Living. TILA is also for young people who continue to live with their foster carers after their care order expires.</p> <p>Examples include: connection to utilities, appliances, white goods, education and consumables. Case managers can assist in making an application. <p>Respite Care</p>	<p>Respite care is planned, regular or one-off, time-limited breaks with an approved carer for the primary carers of children and young people in care. Contact your caseworker to discuss respite care.</p>
<p>ACT Government School Fees</p>	<p>ACT Government Schools and Preschools do not charge school fees. If any problems or issues arise as a result of not paying Voluntary School fees, please contact Families &amp; Students, Complaints &amp; Feedback on 6205 5429.</p>

## Supports for Foster Carers and Kinship Carers

### ACT Together – Foster and Kinship Support

One of the key features of ACT Together is the support we seek to provide to carers.

Children in care have a caseworker, foster and kinship carers caring through ACT Together will have access to support through the Carer Support Program.

The caseworker for the child is involved in aspects of the child's care and supports the placement in a general way. This includes requests for contingencies, arranging

contact, home visits, supporting carers in behaviour management, organising Reviews meeting etc.

Carer Support is there for you and your family. The Carer Support Team has a range of experience in foster and kinship care, case management and providing support to caring families.

The role of carer support includes debriefing, advocacy, referral to other services, annual reviews and compliance checks.

The Carer Support team regularly organises carer coffee and support groups, playgroups and special events, as a way building carer support networks.

In addition, we offer training on a regular basis. Training is developed based on feedback from carers.
